



**Memorandum of Understanding

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and executed on 12/05/2021 at Bharuch.

BY AND BETWEEN

Narmada College of Management, located at Zadeshwar, Bharuch, Gujarat hereinafter referred to as the "NCM" as THE FIRST PART.

Narmada College of Science and Commerce, Zadeshwar, Bharuch, Gujarat hereinafter referred to as "NCSC" as THE SECOND PART.

And

Bharuch District Management Association, located at 7-X, The Business Hub, Old N. H. 08, Bholav, Bharuch, Gujarat hereinafter referred to as "BDMA" as THE THIRD PART.

NOW, THEREFORE, IN CONSIDERATION OF THE PROMISES AND THE MUTUAL COVENANTS. MOU HEREIN AFTER SET FORTH, THE PARTIES HEREBY AGREE AS FOLLOWS:

OBLIGATIONS OF BDMA:

1. Allow faculty participation in all Forums at marginal fees for immersion in functional areas and knowledge extension which can be used for class room discussion.
2. Act as an intermediary in approaching Industry members for regular Industry visit/other assignments for students.
3. Help in sourcing industry experts for Guest Lectures / Mentors for startups/entrepreneurship or otherwise.
4. Allow 5 students for attending the training, in every programme of all Forums, without fees.
5. Extend the guest talk of BDMA Speakers to NCM during and after College hours.
6. Promote Industry Institute linkage by the Industry Professionals participating in designing of syllabus, assigning Industry sponsored projects/ consultancy assignments/MDPs, etc.
7. Conduct certificate programme in areas of current knowledge with joint signatories.

OBLIGATIONS OF NCM AND NCSC:

1. Allow access to onsite reading of Library books, international journals and periodicals of NCM and NCSC for BDMA members.
2. Help in executing various Forum Programmes by College students who will work as volunteers.
3. Conduct / assist in conduct of minor research projects for BDMA or its member companies.
4. Conduct joint programmes of NCM/NCSC with BDMA and its other associates at College campus for the benefits of students and professionals.
5. Help in conducting programmes of academic nature through College faculty members.
6. Promote active participation of students in BDMA programmes for Youth, Student Forum activities, etc.
7. Conduct certificate programme in areas of current knowledge with joint signatories.

All above programme will be organized at mutual convenience of NCM, NCSC and BDMA. Either party to the MOU shall have right to modify the MOU with due consultation.

Validity of MOU

This MOU shall be effective from 12/05/2021. Thereafter, with mutual consent the MOU may be extended for a mutually agreed period and with any changes acceptable to either party.
