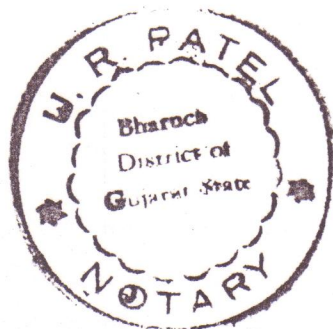

After careful study of the same, Permanent Affiliation for all the above as mentioned courses are hereby granted with effect from 15th June 1998.
