


The guest speaker event with Vikul Kothari was organized to provide our audience with insights into the world of Business. Vikul Kothari is widely

- 2. Value Proposition: This outlines the unique value or benefits that a company offers to its customers. It answers the question, "Why should customers choose your product or service over the other alternatives?"
- 3. Channels: Channels represent the various ways a company reaches its customers and delivers its value proposition. This can include distribution channels, sales channels, and communication channels.
- 4. Customer Relationships: This component defines the type of relationships a company establishes with its customers. It can range from personal assistance to self-service, depending on the nature of the business.
- 5. Revenue Streams: Revenue streams describe how a company generates income from its customers. This includes the pricing strategies, revenue models, and sources of revenue.

At this point Dr. Shah shared a wonderful story of Charles Blondin and Harry Colcord to illustrate what true faith is!

Blondin was the foremost tightrope walker of his time. He gained worldwide fame in 1859 as the first person to cross Niagara Falls. Colcord was his friend and manager. Blondin walked 160 feet above the falls several times back and forth between Canada and the United States. Over several weeks, Blondin walked backward, blindfolded, back flipped, pushed a wheelbarrow, and even cooked an omelet during one of many trips across the rope.

At one such daredevil stunt Blondin stopped suddenly and asked the audience "Do you believe I can carry a person across in this wheelbarrow?" The crowd enthusiastically responded, "Yes! You are the greatest tightrope walker in the world. We believe!" "Okay," said Blondin, "Who wants to get into the wheelbarrow." As far as the Blondin story goes, no one did at that time! But in August of 1859, Charles Blondin's manager, Harry Colcord, did ride on Blondin's back across the falls.

This unique story illustrates a real life picture of what faith actually is. The crowd watched these daring feats. They said they believed. But, their actions proved they truly did not believe. Colcord had faith that he could accomplish these feats, but he also trusted his abilities to complete them. This is the difference between faith and trust. The spectators had faith in Blondin and believed in his abilities. But only Colcord trusted him enough to climb on his back and allow him to carry him across.

A reaction may result in a positive or negative outcome whereas a response is engineered to produce a positive outcome. Reacting is emotional, responding is emotional intelligence.




